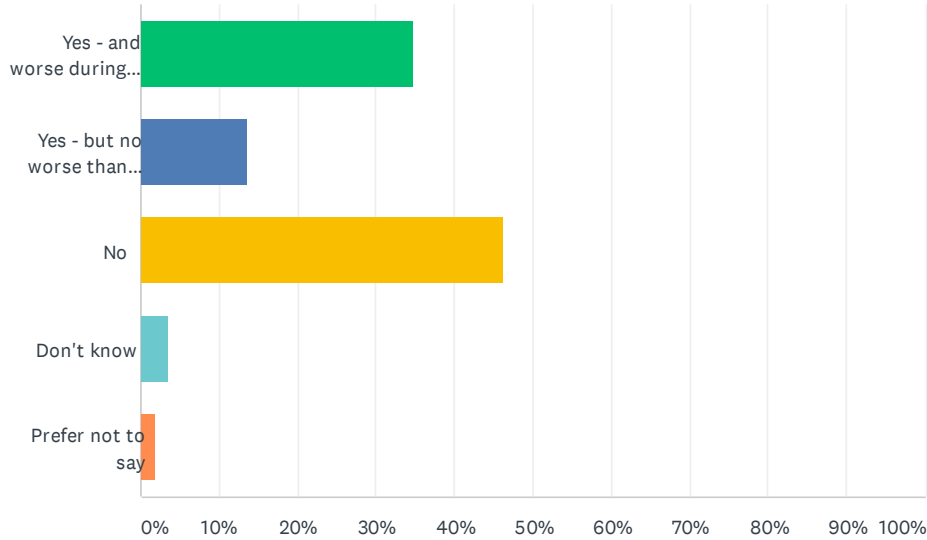

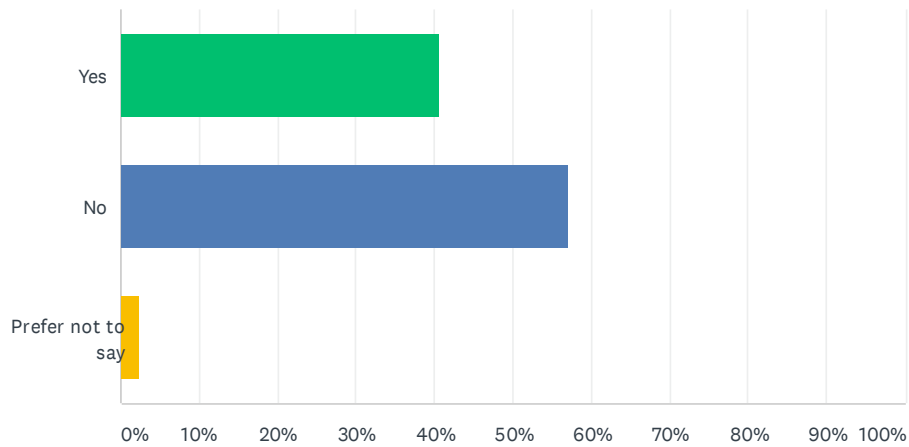

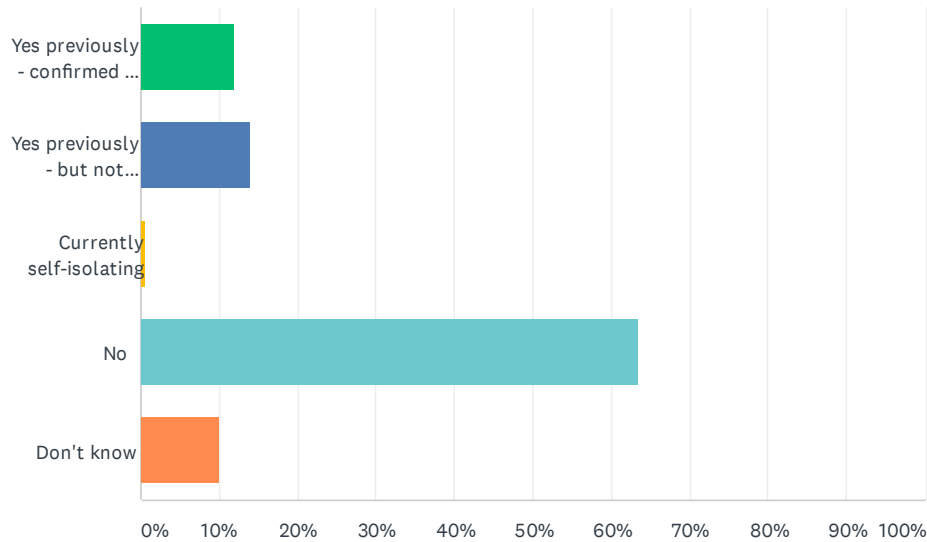

Q15 Do you believe that you previously have, or may have, contracted Coronavirus?

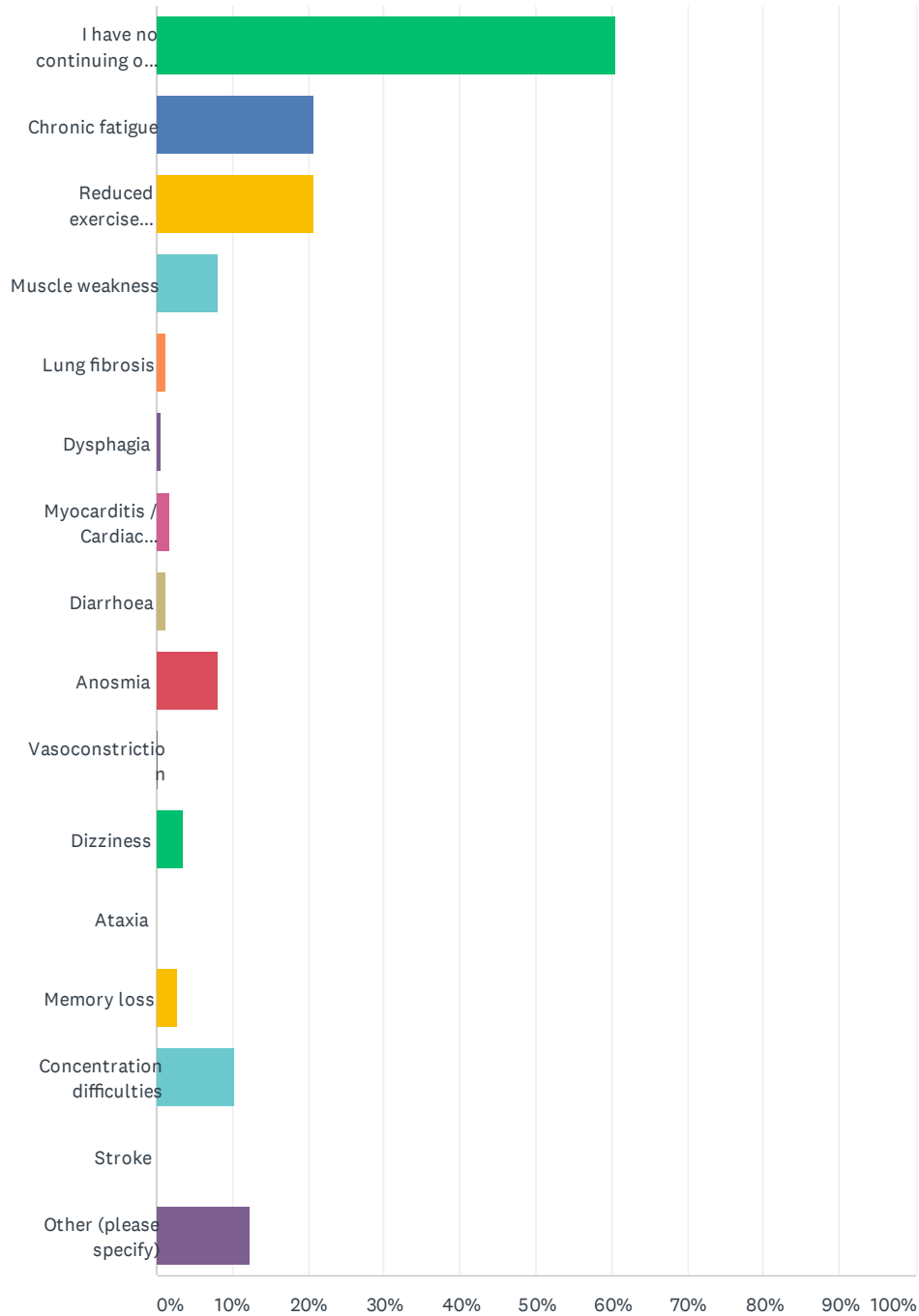

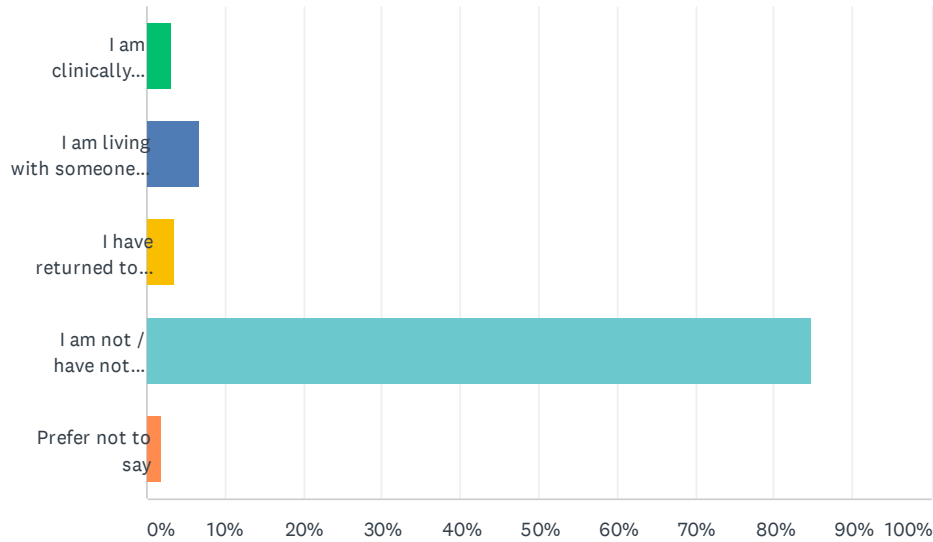

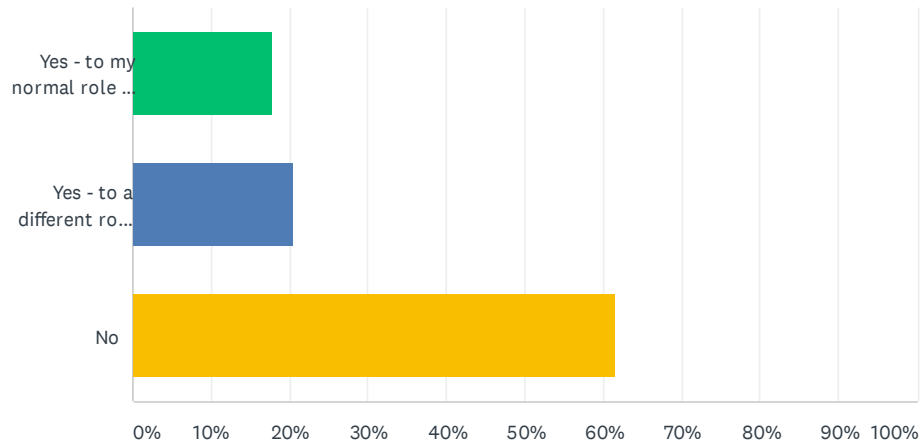

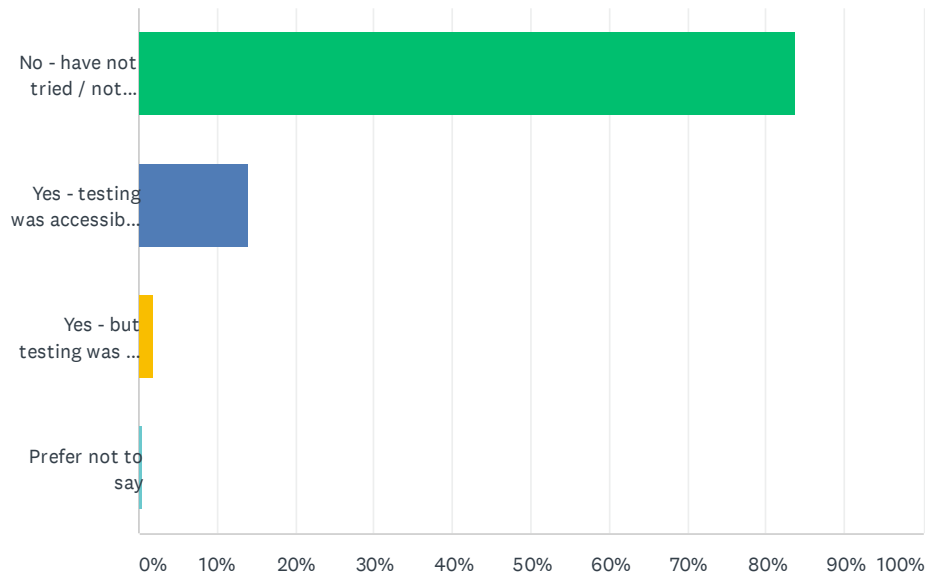

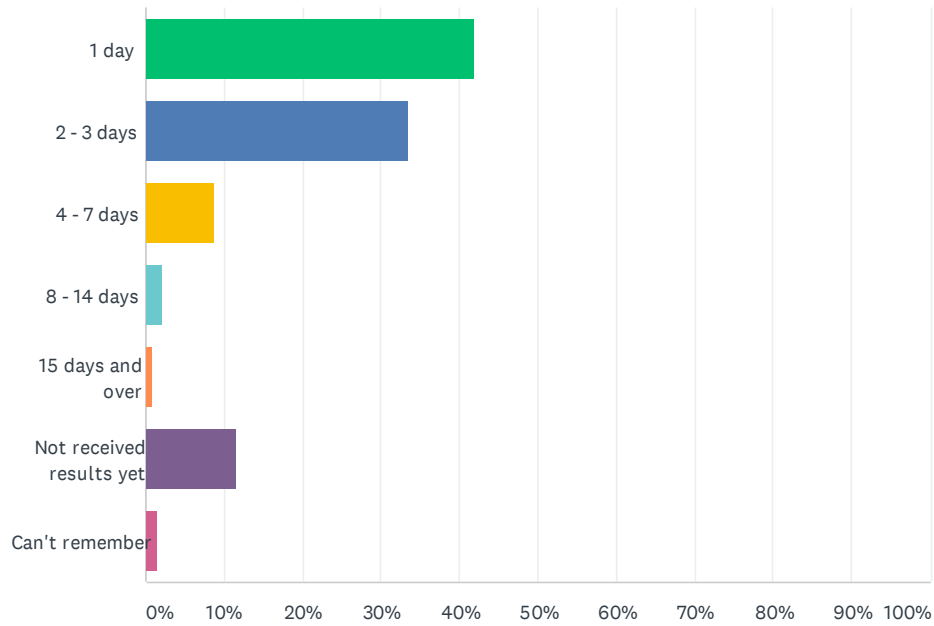

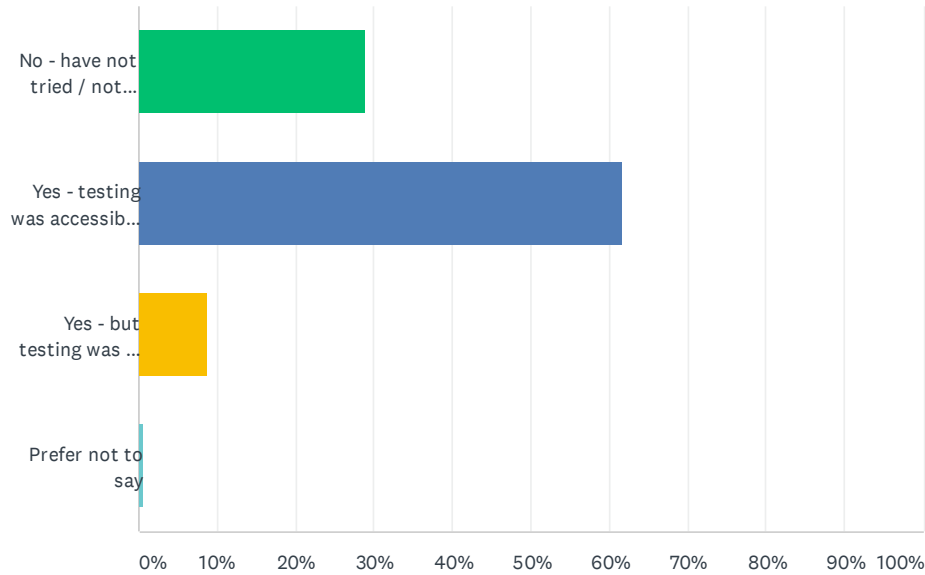

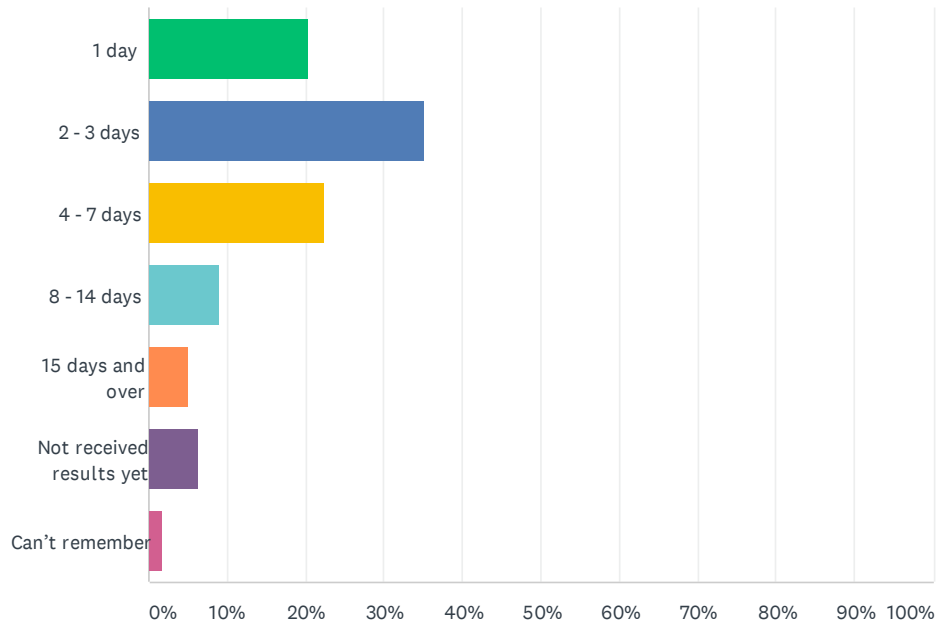

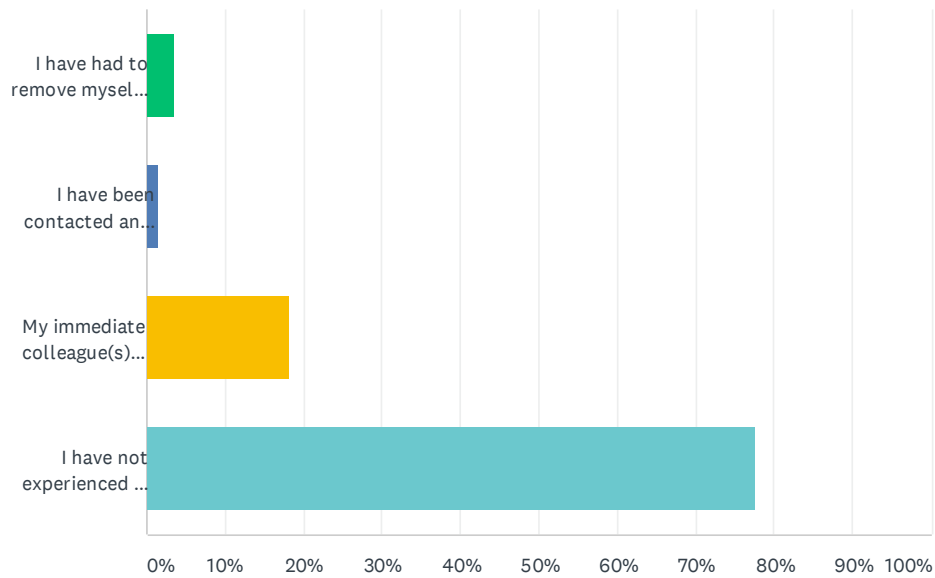

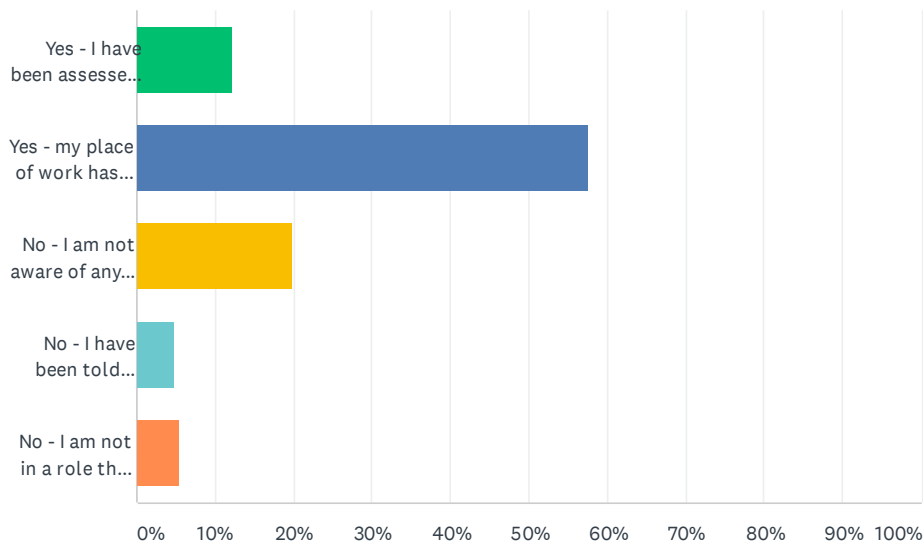

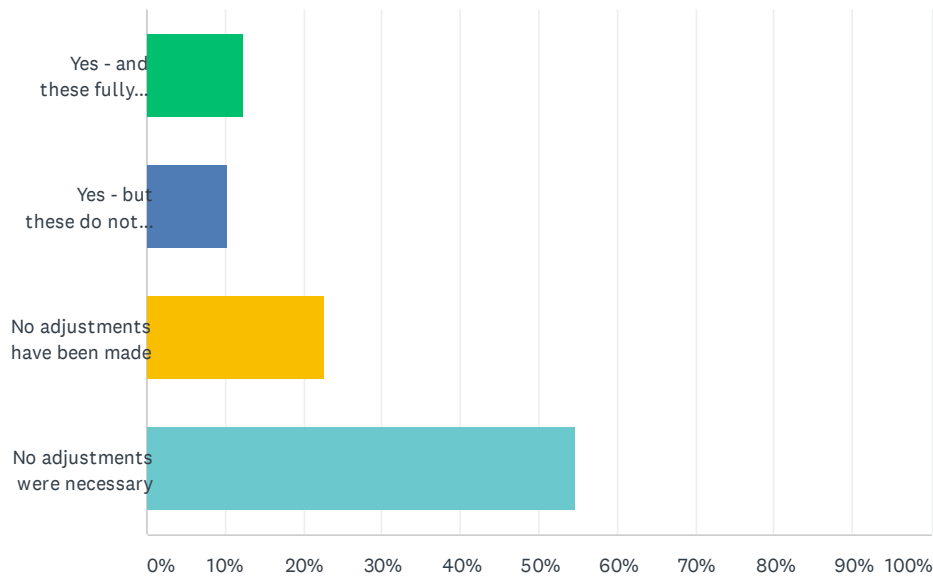

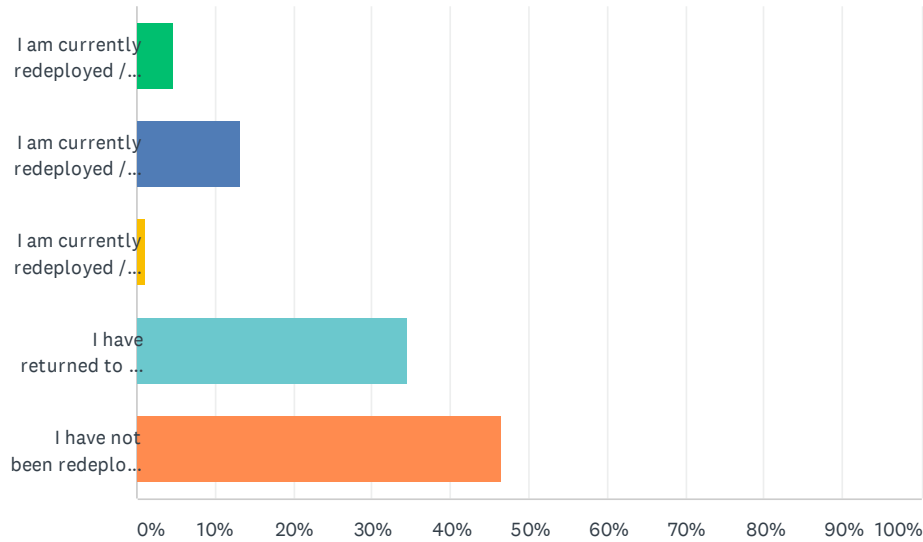

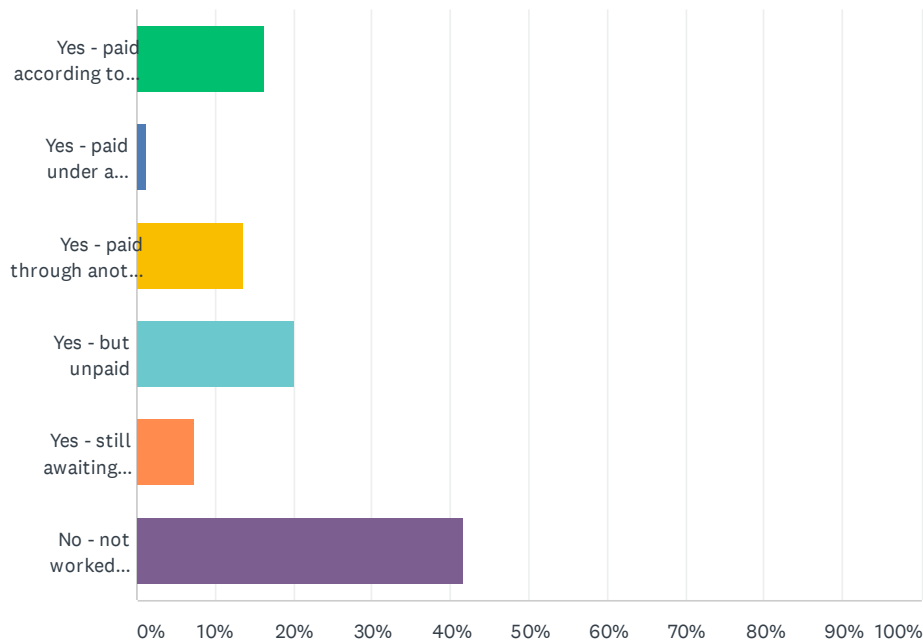

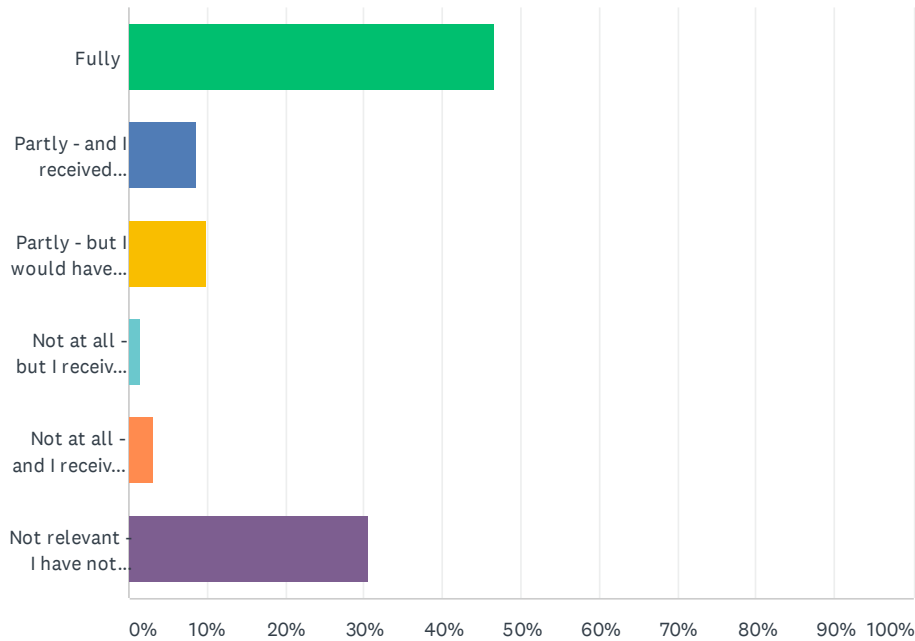

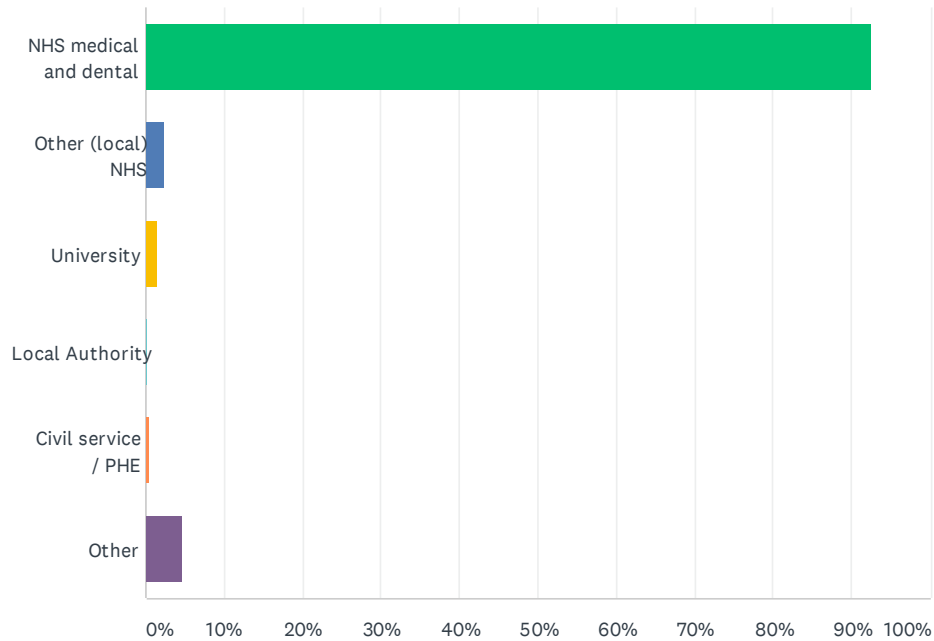

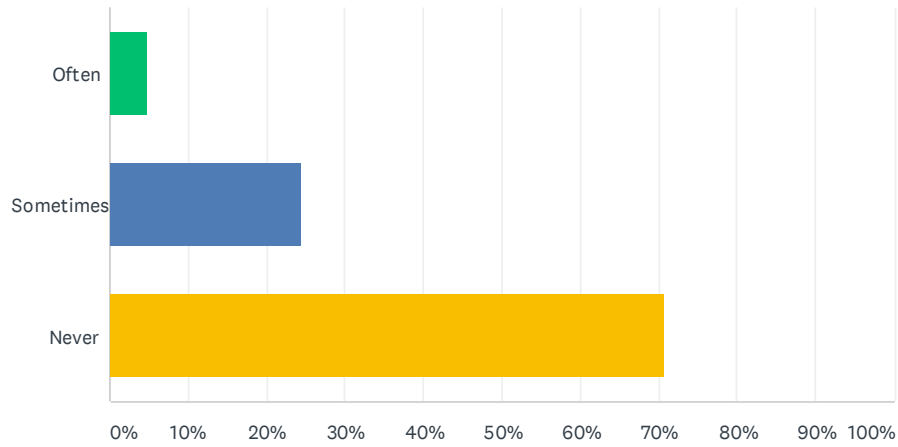

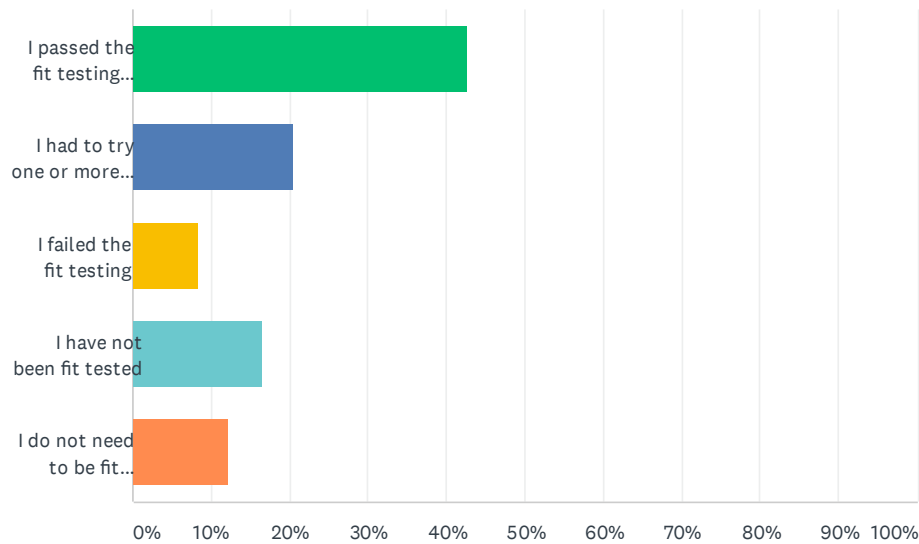

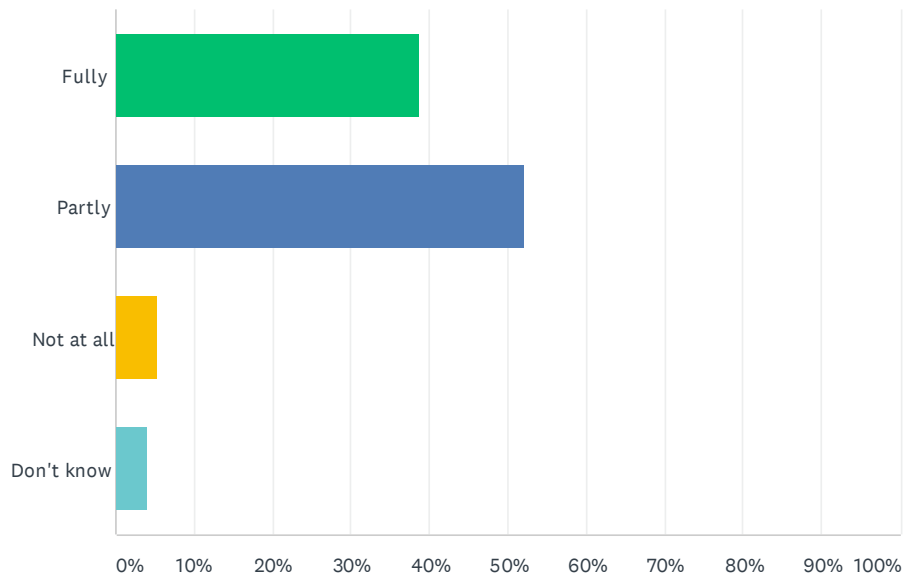

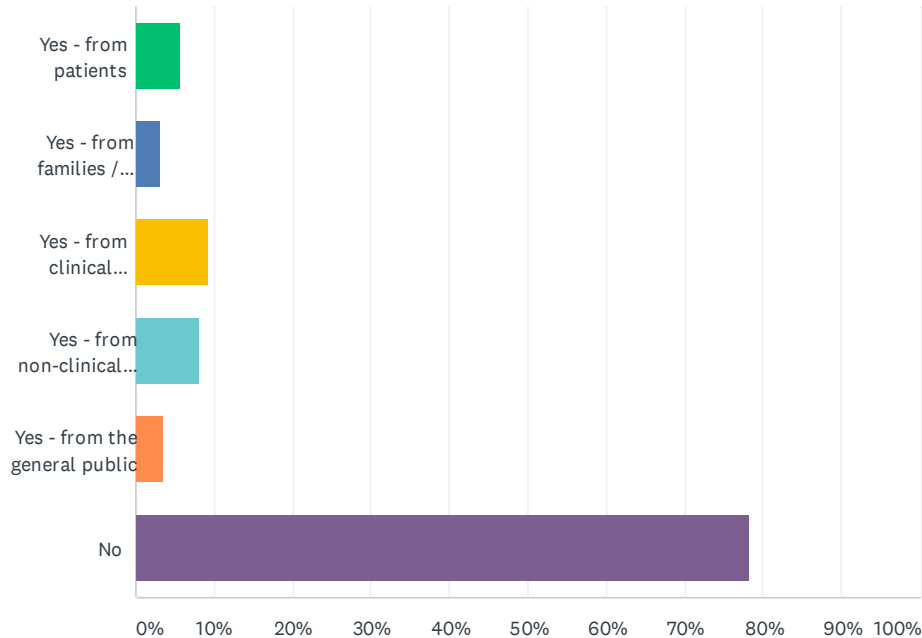

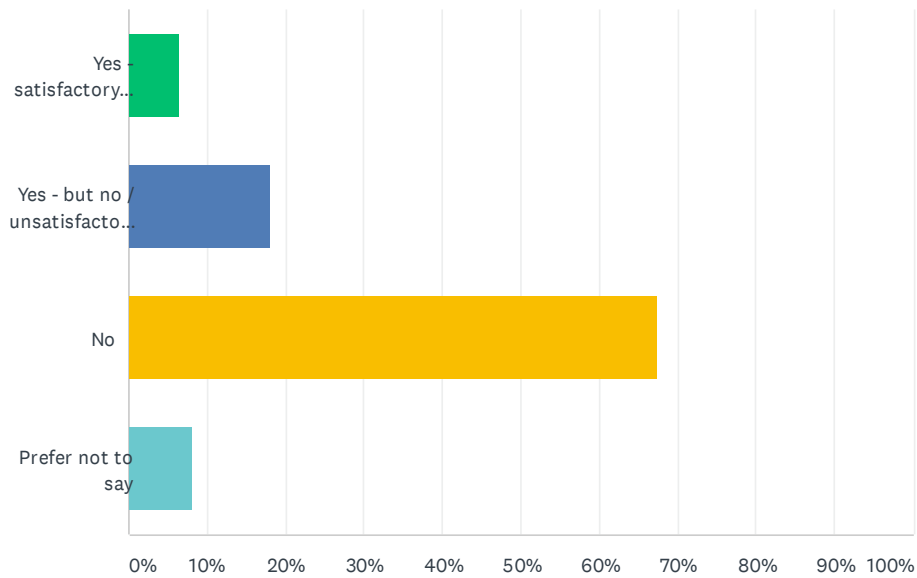

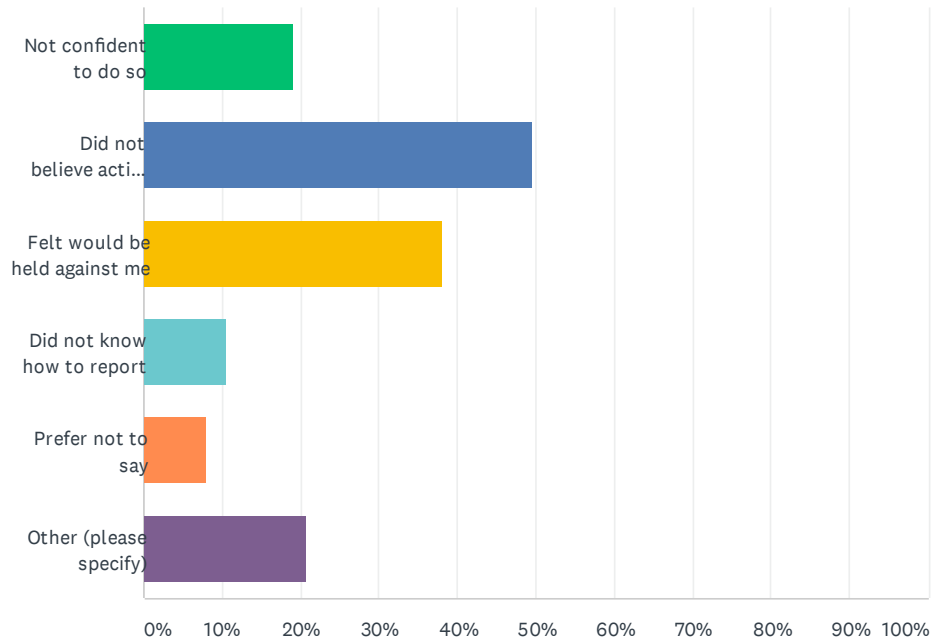

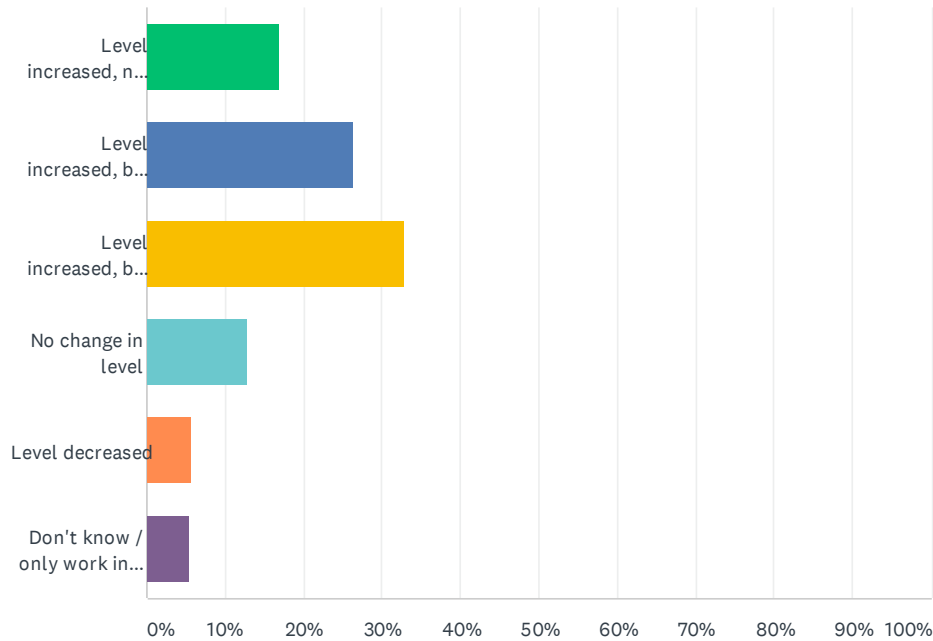

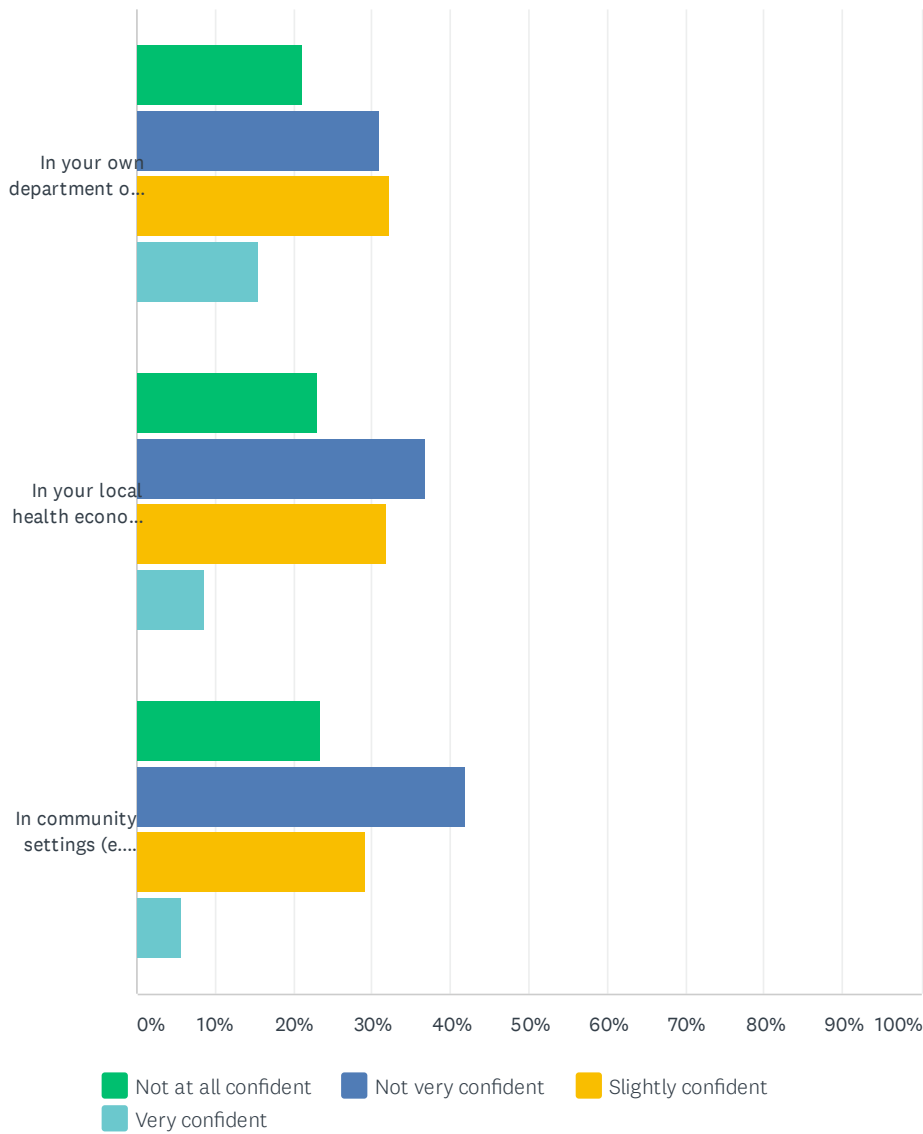

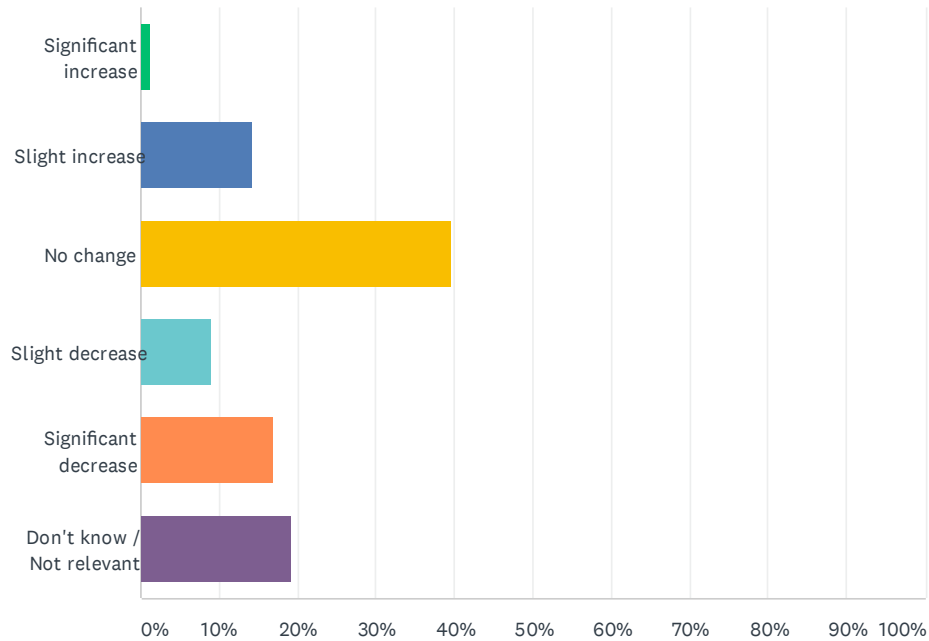

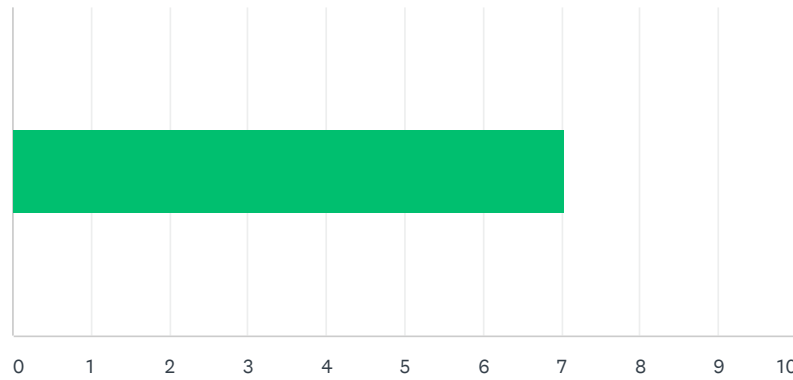

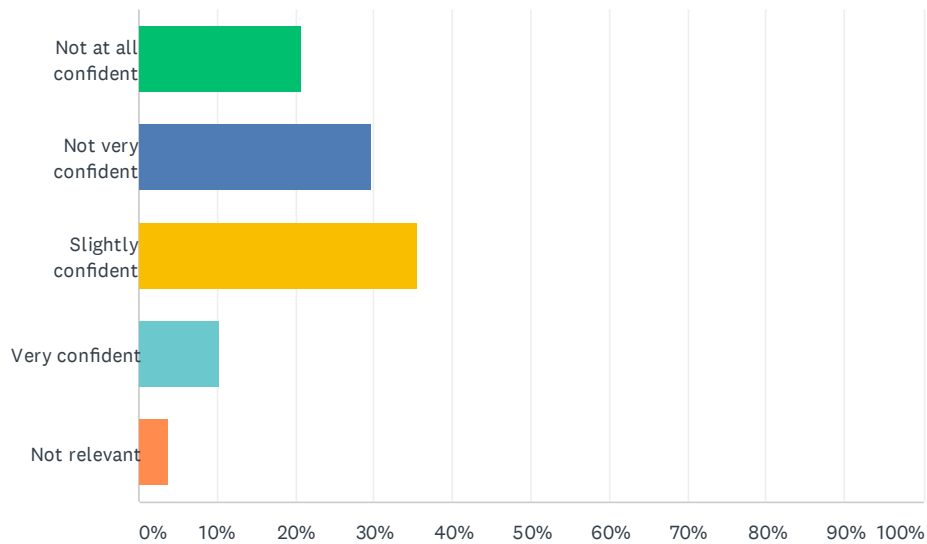

Q41 How confident are you about your ability to manage patient demand if there is a second peak of Covid-19 (national or local)?

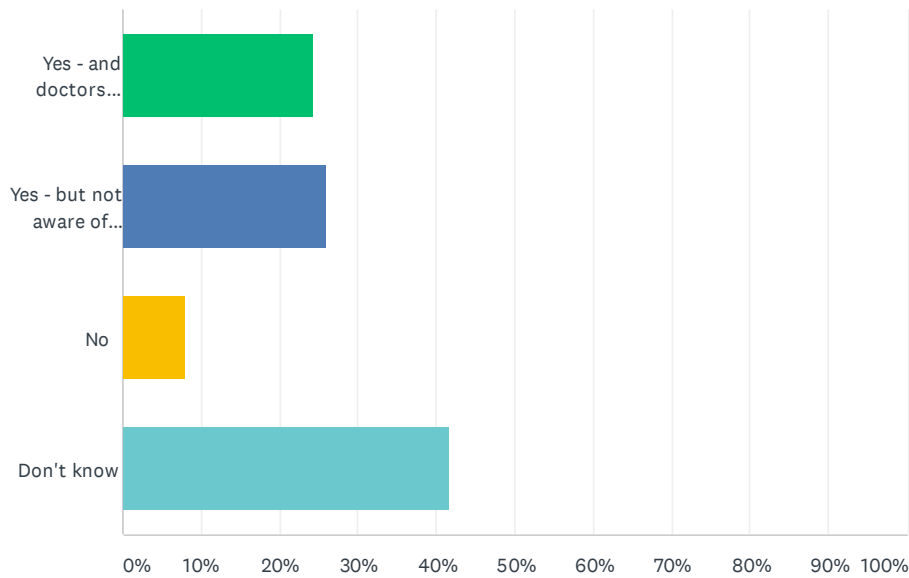

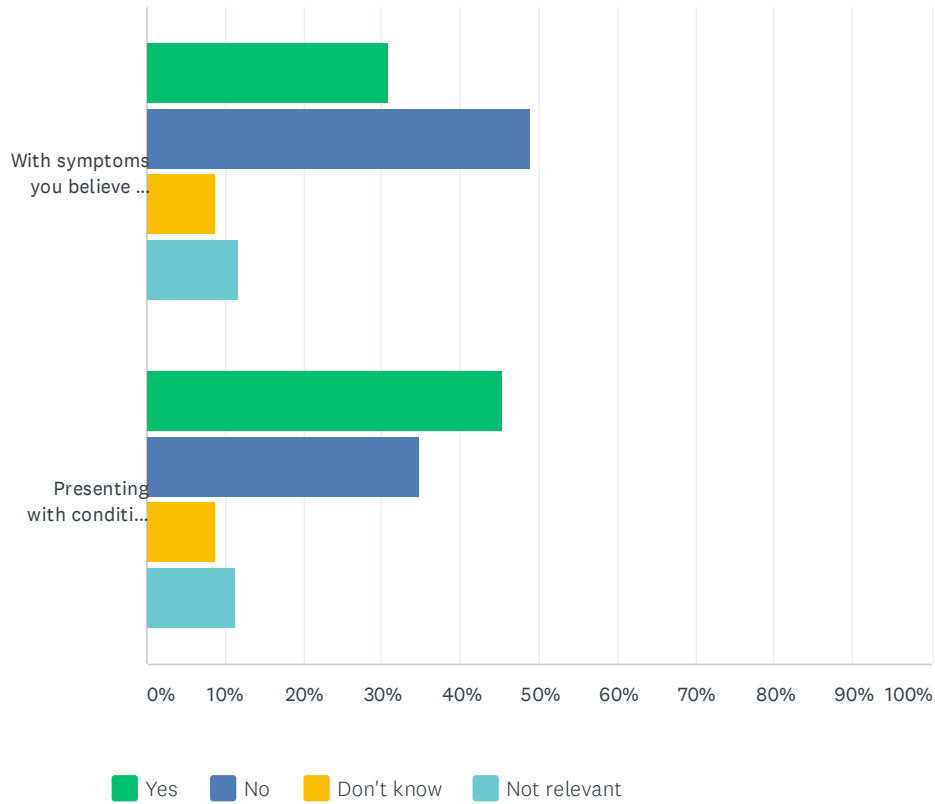

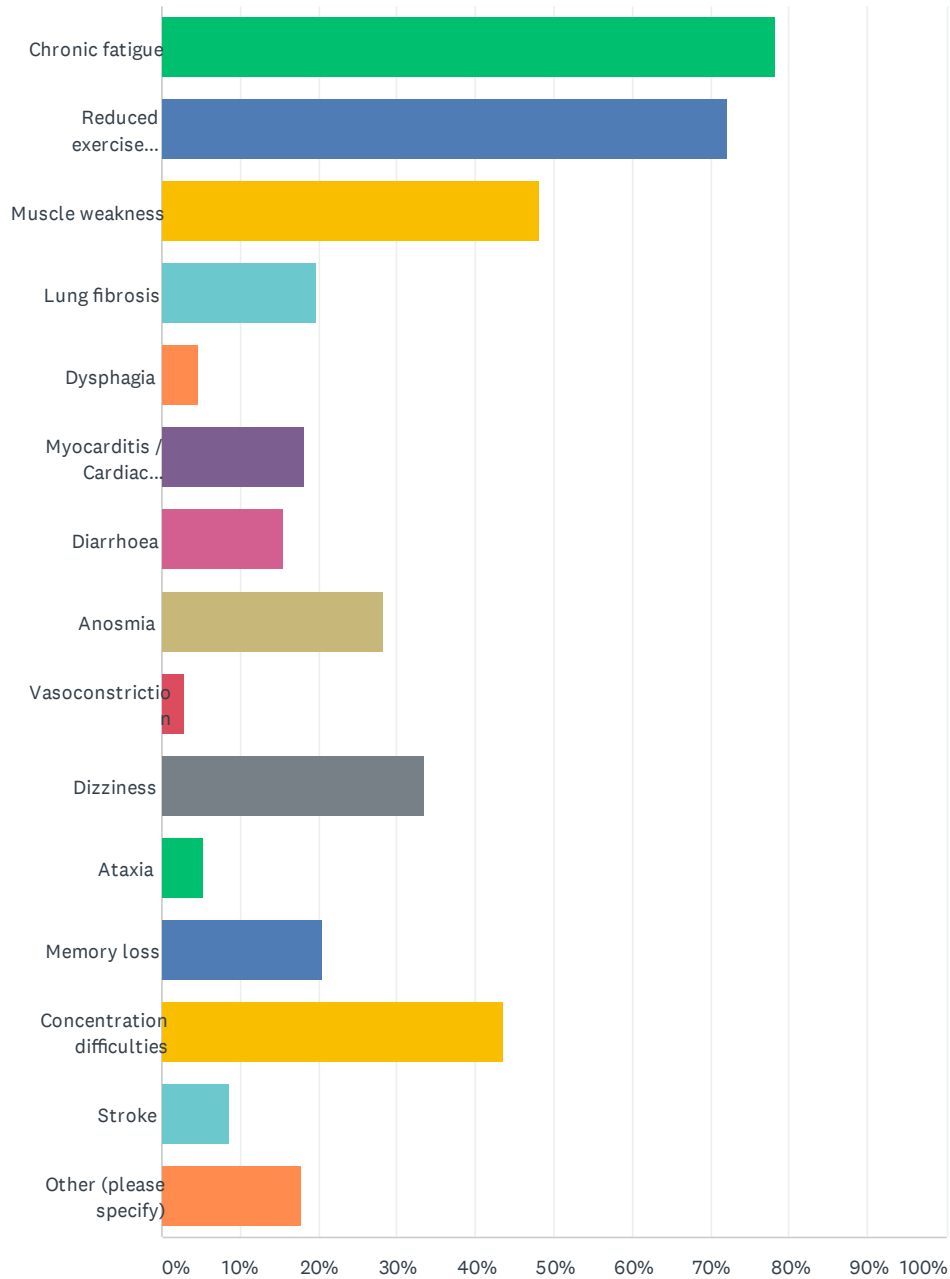

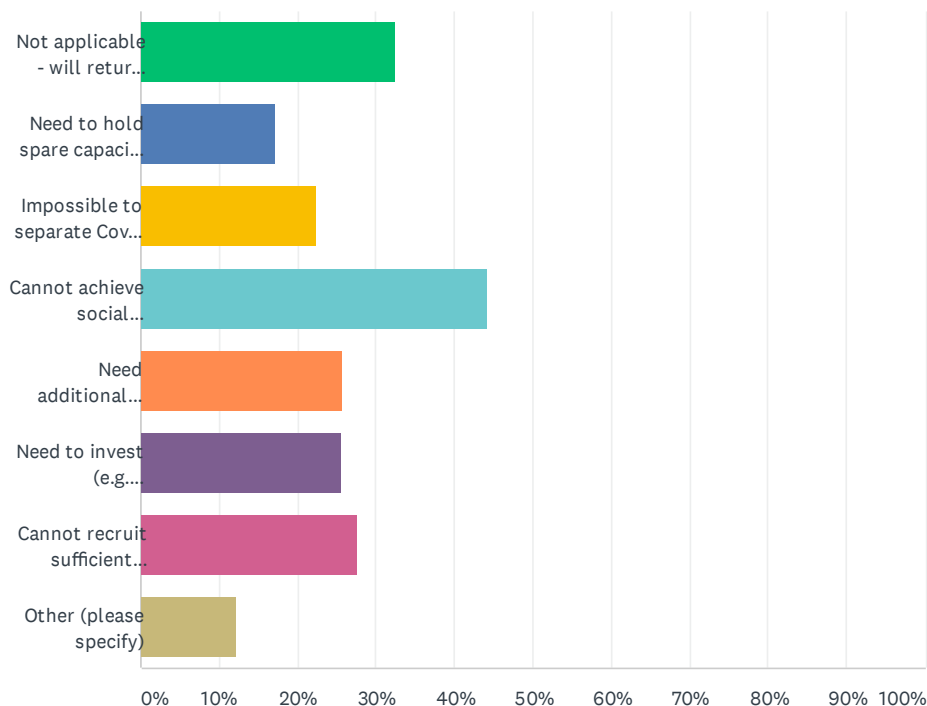

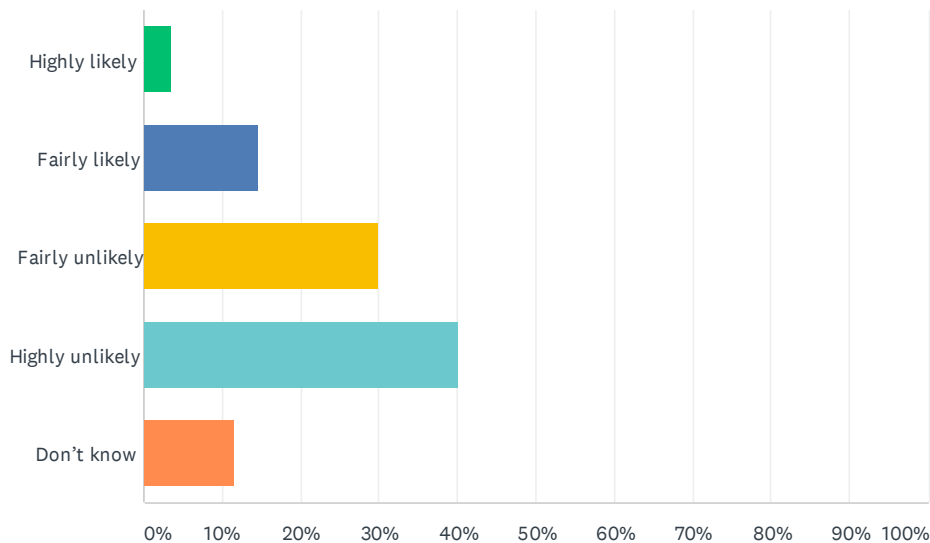

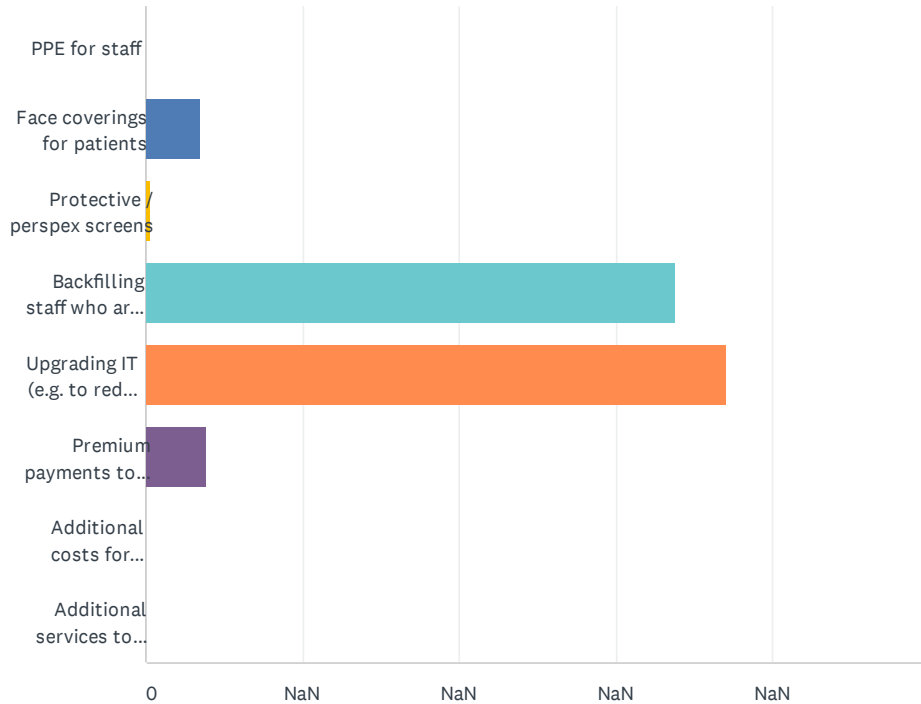

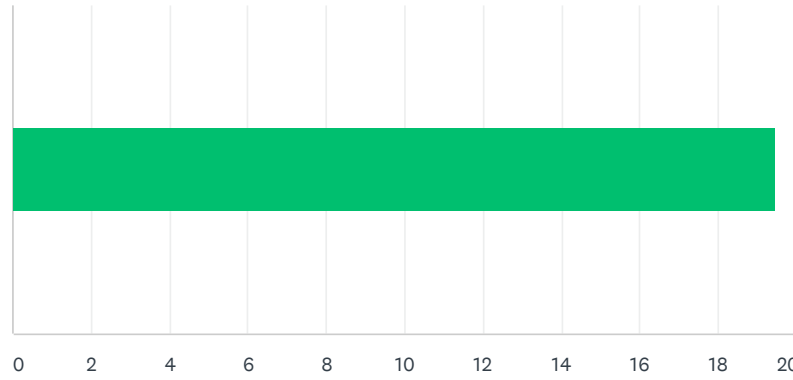

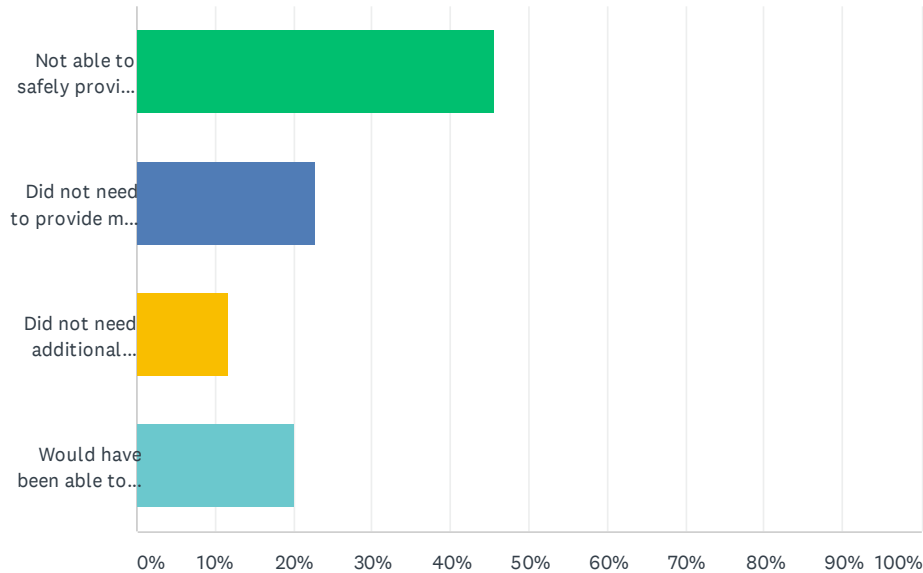

Q53 Which services, if any, would you have been able to safely provide / provide more of in the period since March had additional Covid funding been available to help manage infection risks?

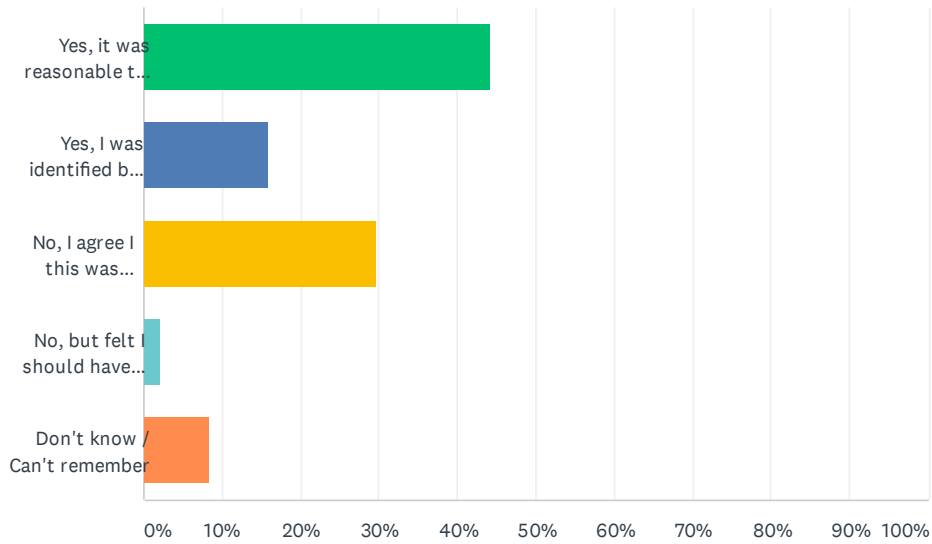

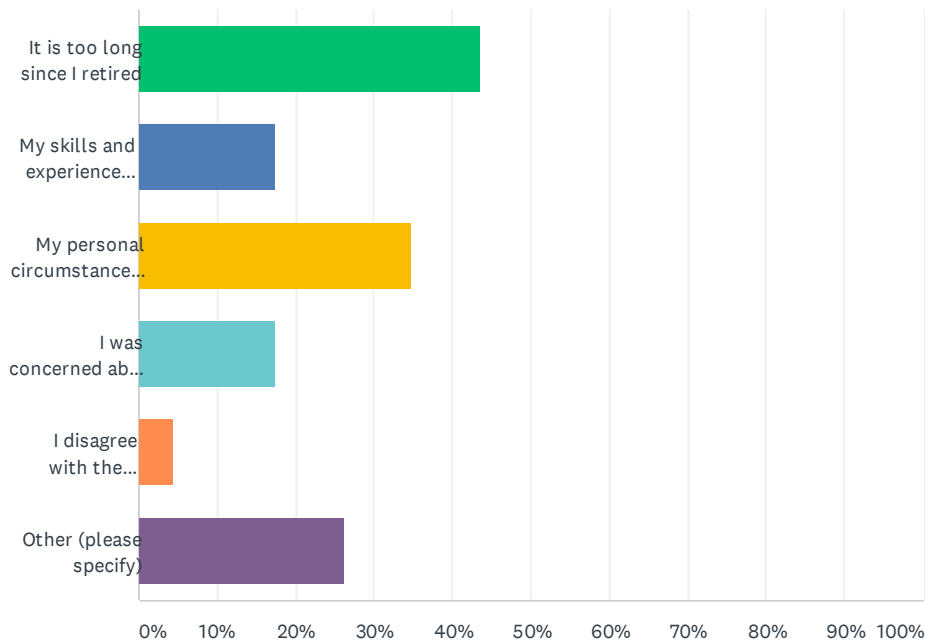

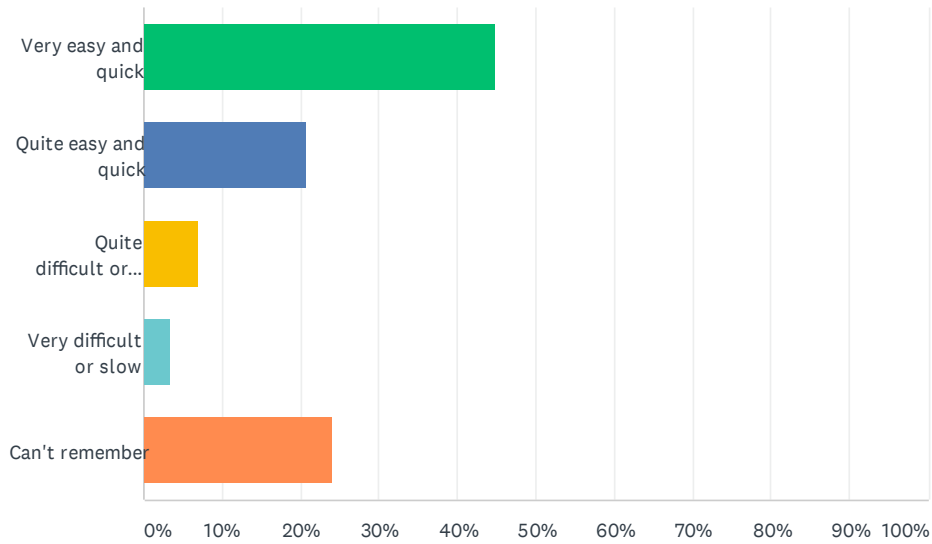

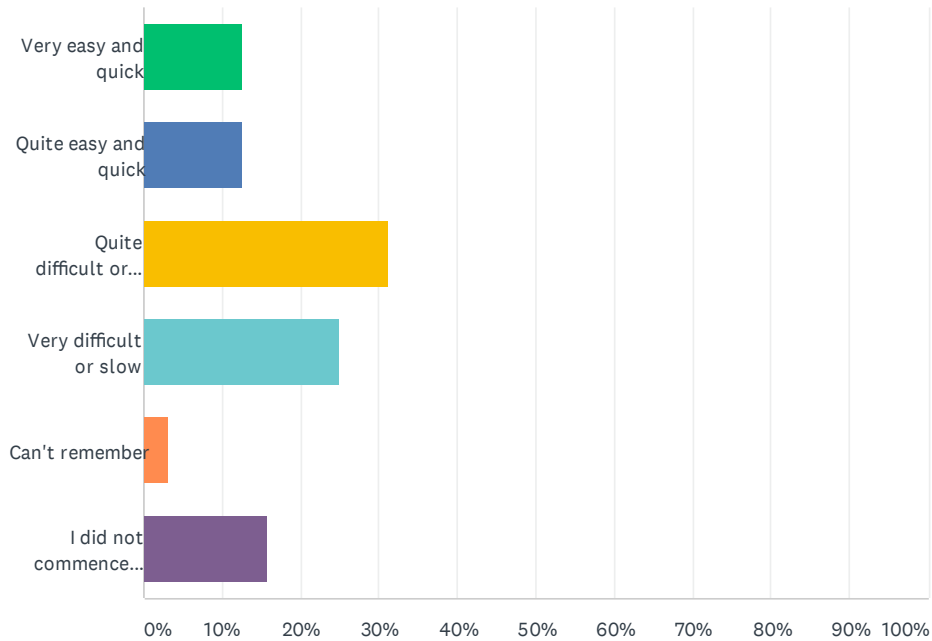

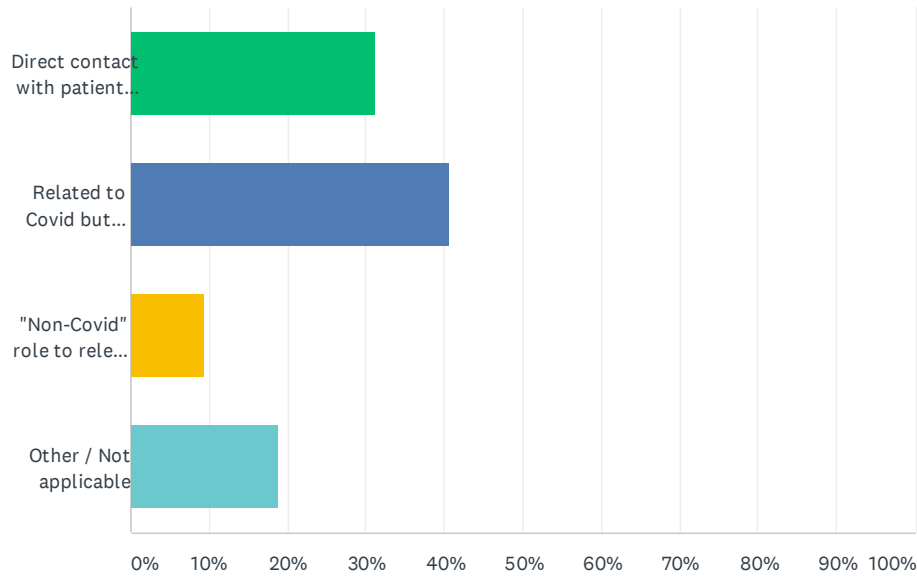

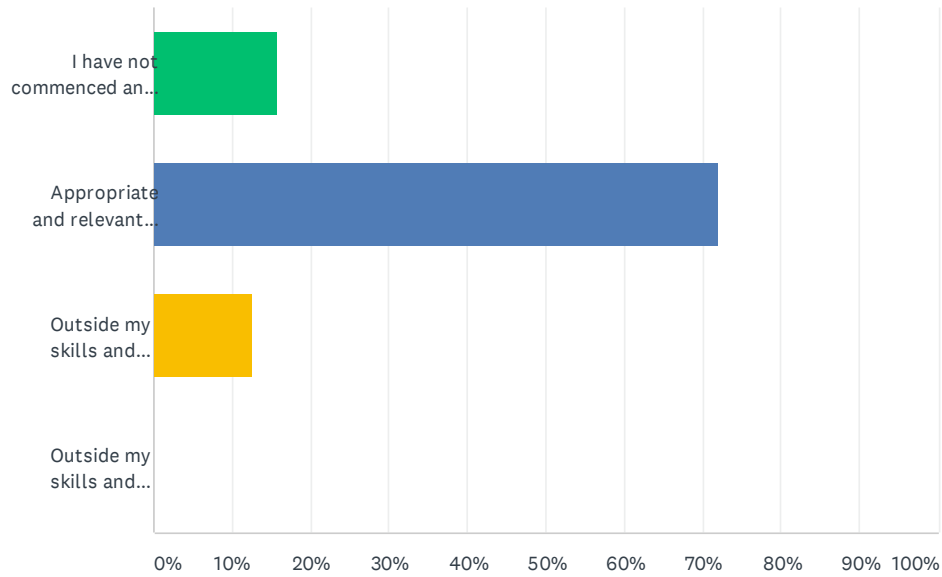

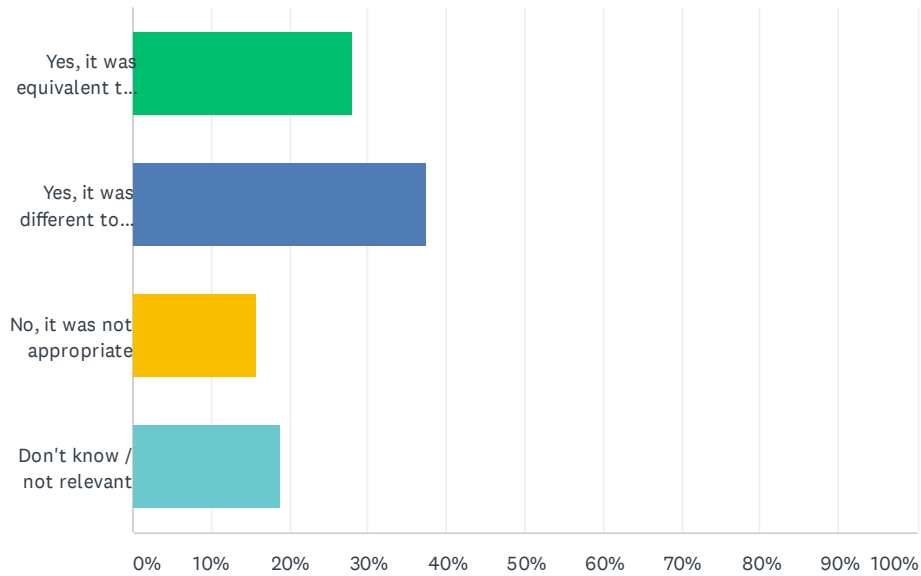

Q60 In your opinion, was your level of pay appropriate to your role during the pandemic?

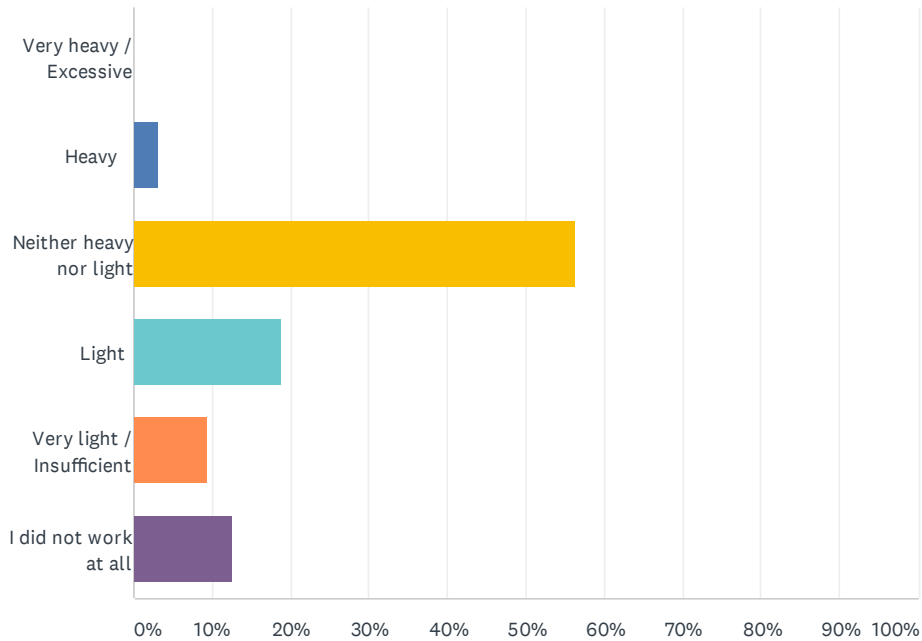

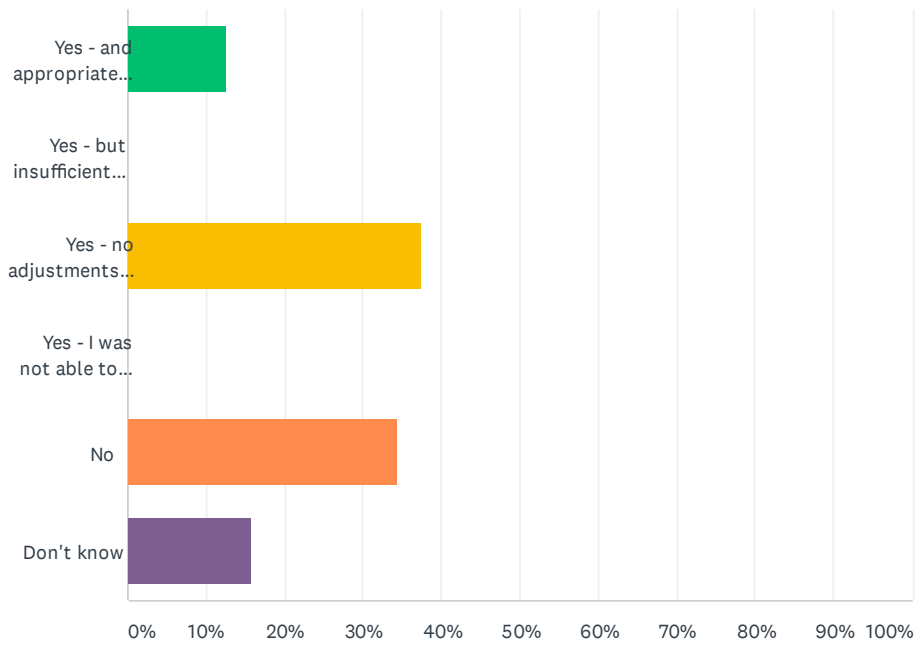

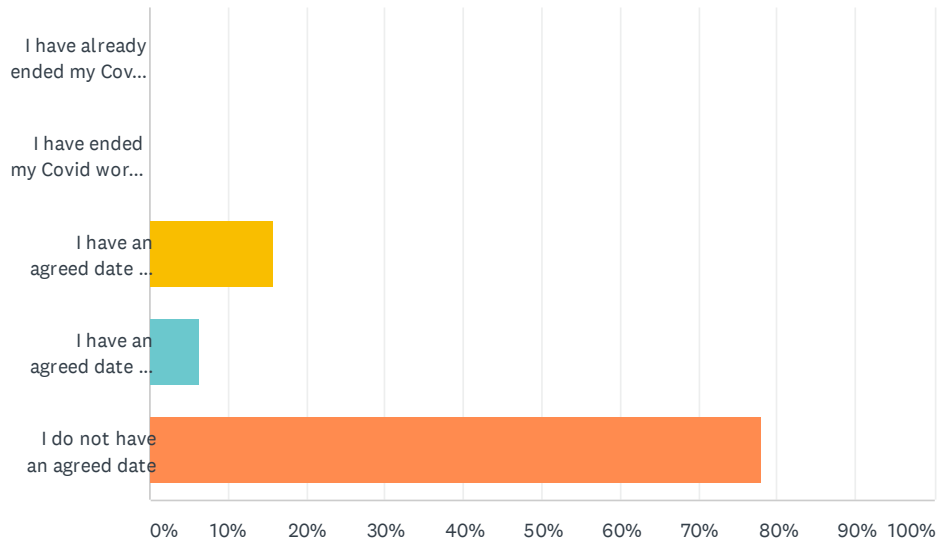

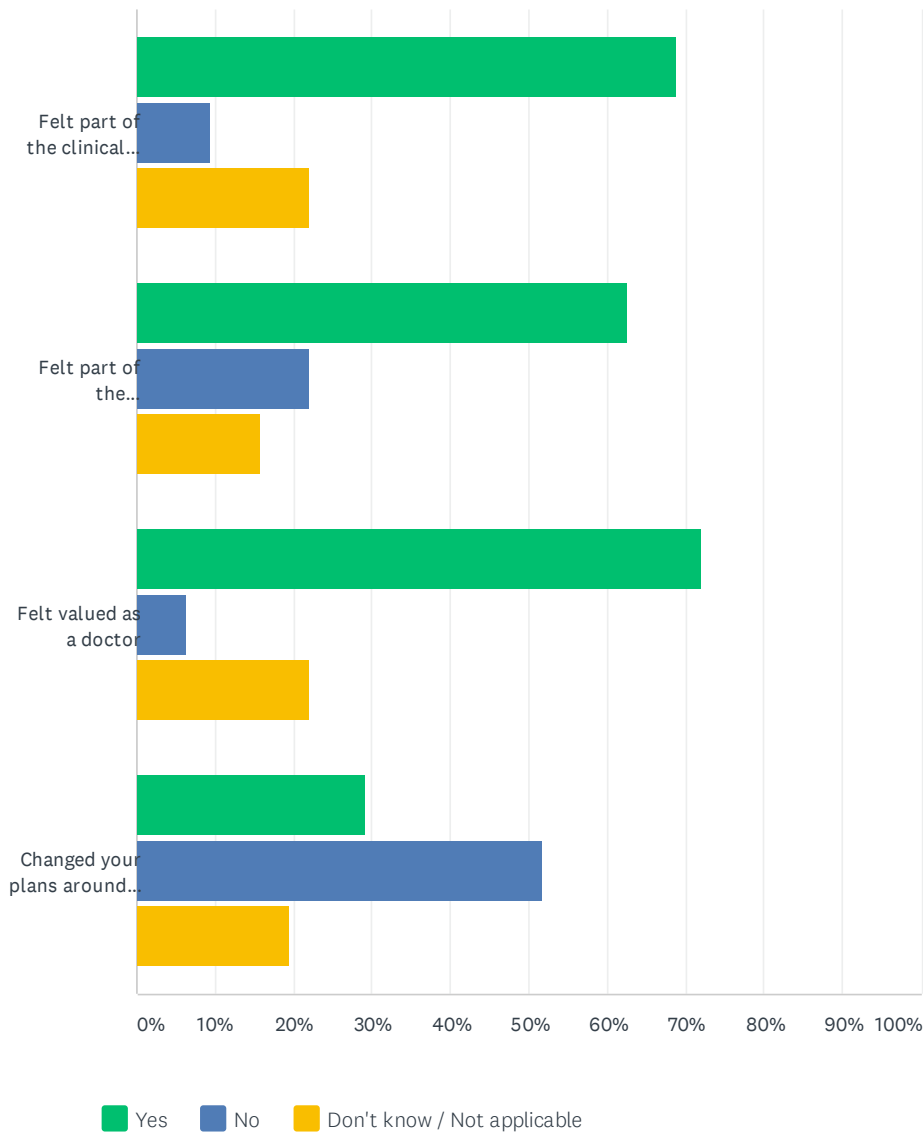

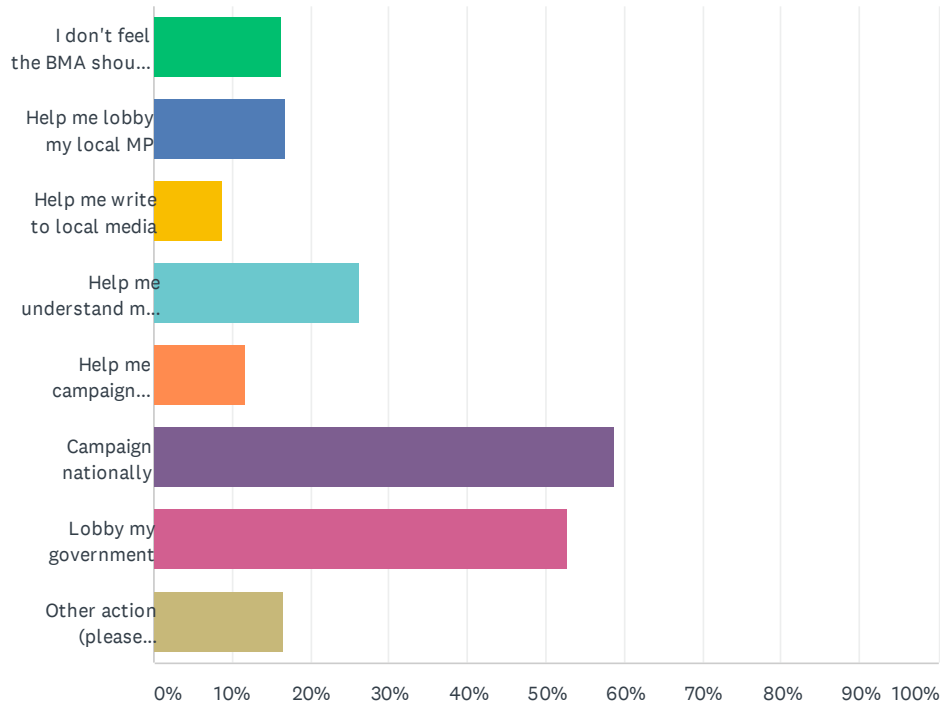

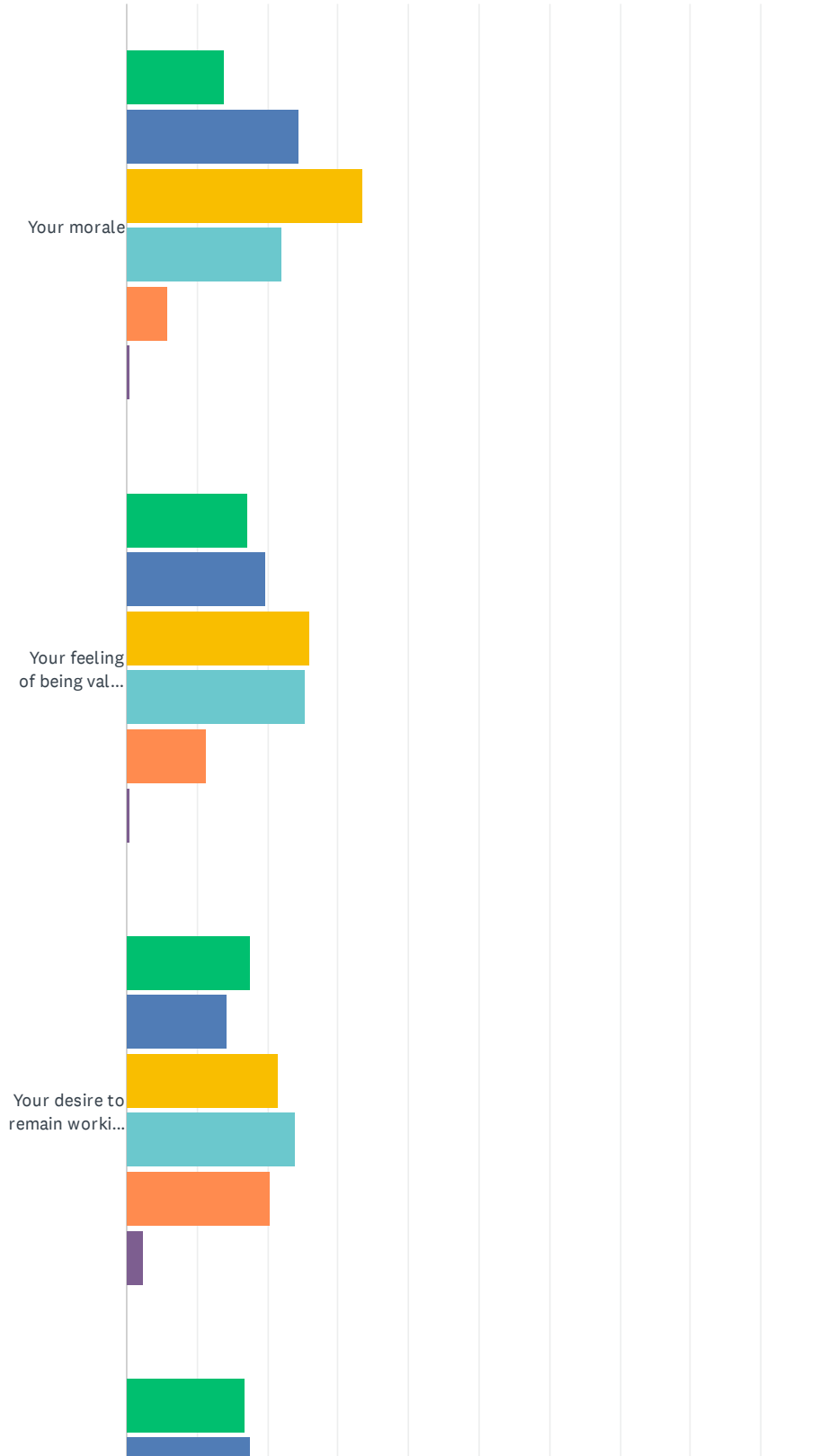
